### 1. REFERENCE TO THE “Paris Aéroport & You” WEBSITE

#### 1.1 Publisher

#### 1.3 Ownership

## **2. TERMS OF OPERATION OF PARIS AÉROPORT & YOU**

The Paris Aéroport & You community is made up of Members (persons who are invited and/or who wish to register and who have accepted these terms of use), who may, if they so wish, give their opinion independently on various topics by participating in surveys carried out by Aéroports de Paris for research purposes.

### **2.1 Membership to the Paris Aéroport & You community**

#### **i. Restrictions on registration**

Only individuals over 18 years of age and contacted for these purposes by Aéroports de Paris may, should they so choose, become Members of the Paris Aéroport & You community.

Minors may not participate in the Paris Aéroport & You community's studies or services.

Aéroports de Paris encourages parents (or persons exercising parental responsibility) to monitor their children when they are online, due to content that may be harmful to minors.

#### **ii. Registration**

Aéroports de Paris shall send, at the request of the targeted person or based on a separate proposal linked to his/her professional activities, a registration form by email.

To join the Paris Aéroport & You community and take part in surveys/discussions, each individual must complete the online registration form and create a username and password.

Each person who completes the registration form will receive an email from Aéroports de Paris confirming receipt of the registration form and inviting them to log in to the Paris Aéroport & You

Portal by clicking on the link contained in the email in order to validate their registration to the Paris Aéroport & You community.

By clicking on the link to the Paris Aéroport & You Portal contained in the confirmation email sent by Aéroports de Paris, the registration validation process is completed, and the person becomes a Member of the Paris Aéroport & You community.

All validly registered Members can take part in online discussions and forums organised on the Paris Aéroport & You website and respond to surveys sent by Aéroports de Paris.

## **2.2 Rights and duties of Community Members**

Members agree to receive emails from Aéroports de Paris on a variety of topics.

All Members with access to the services and surveys offered by Paris Aéroport & You are obliged to comply with these terms and conditions of use, and applicable laws and regulations, notably with regard to the protection of intellectual property rights, the protection of privacy and personal data.

All Members are free to decide whether or not to respond to the questionnaires they receive.

Each Member that takes part in one or more surveys shall automatically be entered into the prize draw(s) organised by Paris Aéroport & You, without any obligation to purchase, the rules for which are available on the Portal.

Members agree to respect the rules of good conduct when answering questions. Abusive, defamatory, racist, sexist, reactionary and pornographic messages will not be processed. If an offence is committed, Aéroports de Paris shall have no option but to deny the Member in question access to the Portal and remove them from the Community.

Membership to the Paris Aéroport & You community is personal. All Members have a duty to contribute to the overall security of the information provided. Specifically, Members must not grant access to the Paris Aéroport & You Portal to unauthorised persons or share their username and password with third parties.

Members of the Paris Aéroport & You community may be asked, when using the Paris Aéroport & You community, to share, publish on the Paris Aéroport & You community or send to Aéroports de Paris, via the Paris Aéroport & You community, content including photos, videos and text.

Each Member represents and warrants that they are the legal owner of any content that they may post on the Paris Aéroport & You community, or that they may send, via the Paris Aéroport & You community, to Aéroports de Paris, and that the publication or use of said content on or by the Paris Aéroport & You community, does not infringe the rights of third parties, notably the right to privacy, copyright, trademark or any other intellectual property rights.

By submitting, publishing or posting content on or through the Paris Aéroport & You community, Members grant, free of charge and non-exclusively, to Aéroports de Paris, the right to reproduce, copy, use, amend, modify or repost this content on any other internal communication medium of Aéroports de Paris or of its subsidiaries or partners, by any appropriate means and through any method. This authorisation is granted by the Member for a period of ten years from the date of first use of said content.

The Member guarantees that he/she owns all rights to use said content, in accordance with applicable laws and regulations on copyright and other intellectual property rights.

### **2.3 Availability of the Paris Aéroport & You website**

Aéroports de Paris shall endeavour to ensure the Paris Aéroport & You Portal remains accessible at all times but is under no obligation to do so. Aéroports de Paris may, without notice, suspend access, for technical or other reasons, without being held liable for the consequences of any interruption.

Accordingly, Aéroports de Paris does not guarantee that the surveys and services offered by the Paris Aéroport & You website are free from interruption, delay, security incident or error.

### **2.4 Cancelling your membership**

All Members are free to leave the Paris Aéroport & You community at any time. To unsubscribe, Members must click on one of the links available on the Paris Aéroport & You Portal or in any of the emails sent in relation to their membership to the Paris Aéroport & You community.

Furthermore, Members may send a request to unsubscribe to Aéroport de Paris at the following email address: [support@you.parisaeroport.fr](mailto:support@you.parisaeroport.fr). Any requests to unsubscribe will be processed within fifteen days of the date of receipt.

In both cases, Aéroport de Paris will confirm to the Member in question their deregistration from the Community.

As soon as the unsubscription of the Member in question has been registered, the Member will no longer be contacted in connection with Paris Aéroport & You.

### **2.5 Personal Data**

All personal information provided by Members upon registration and throughout their use of the Community, will be used by Aéroports de Paris in compliance with applicable laws and regulations on the protection of privacy and for the sole purposes of sharing information and objective opinions between the Members and with Aéroports de Paris. This information will not be used for any other processing.

This data is collected with the consent of the Members and only the persons in charge of the management of the community and their authorized service providers can access it.

The personal data collected in connection with such processing is as follows:

- Basic identity
- Personal contact details
- Notices and information shared by the member
- IT traceability
- Photo
- Recorded video

The data subjects affected by such processing activity are as follows:

- The Members

In all circumstances, this data may not be stored for more than three (3) years from the date of last connection to the My Paris Aéroport & You portal.

Aéroports de Paris undertakes to take the following necessary measures:

- (i) Ensure the implementation of technical and operational measures appropriate for maintaining the security, confidentiality and integrity of Personal Data relating to this agreement in order to prevent, notably:
  - Any illegal, unauthorised, malicious or fraudulent use of the Data processed,
  - Damage to Data,
  - Any access to said Data except where expressly authorised beforehand,
  - Any unauthorised or illegal processing,
  - Loss, destruction or any accidental damage relating to said Data.
- (ii) Only process the Personal Data for the determined purpose(s);
- (iii) Process Personal Data in a manner that is legal, fair and transparent vis-à-vis the Data Subjects and to limit processing to the Personal Data that is relevant and necessary with respect to the purpose of the Processing;
- (iv) Retain Personal Data in a form permitting identification of the Data Subjects for a period no longer than strictly necessary for accomplishing the tasks for which that Data are necessary;
- (v) Notify the Members of any Personal Data breach;
- (vi) Keep a written register of all the categories of Processing activities carried out under the Agreement.

Members have the right to access, correct and delete their personal data as well as the right to limit the processing of their data. They can also set guidelines for how their data will be handled after their passing.
